### **Collection of School Meals Money and School Meals Debt Policy**

The High Spen Primary School meals collection and debt policy has been adopted to ensure that a fair and consistent approach is taken to debt incurred by parents/carers whose children take school meals.

#### **General Principle**

School meals must be paid for prior to the meal being taken, preferably on a Monday for the week ahead or in exceptional circumstances on the day the meal is taken.

#### **Free School Meal Entitlement**

If parents/carers believe their child(ren) may qualify for free school meals, they should contact Gateshead Council on 0191 433 3000 or ask for an application form from the school office. The school is only allowed to provide a free meal where this is officially approved by the local authority.

#### **Cost of School Meals**

There is no charge for children in Years Reception, Year 1 and Year 2 and they can have a free school meal from the Governments Universal Infant Free School Meals initiative. School meals are available to children in years 3-6 at a cost of £3.00 per day and Nursery at a cost of £2.50 per day, with no cost to those in receipt of free school meals entitlement. Any revision to school meals prices will be notified to parents/carers the term prior to the new charge taking effect.

#### **Payment for School Meals**

School meals must be paid for in advance of meals being taken. Payments can be made via cash at the school office or made online through School Gateway which can be accessed through the app.

Meals may be paid for on a daily, weekly, half termly or termly basis.

When parents/carers log onto School Gateway they can easily see the balance of their account.

#### **Non-Payment**

We understand that there are times when parents may forget to make payment, and therefore we will send a text reminder, and will expect this to be rectified as soon as possible.

Where a child continues to take meals which have not been paid for, the school will contact the parent weekly via text message (Text message 1) detailing the amount of money owed. If the debt continues to accrue, and £30.00 is reached, the school will contact the parent via text message informing them to provide a packed lunch until the arrears are cleared. (Text

message 2). If the arrears are not cleared the school will also contact the parent / carer to ask if they are experiencing hardship which is affecting their ability to pay. Under these circumstances the parent / carer should be invited to apply for free school meals and / or speak confidentially to the Head Teacher.

If the school are unsuccessful in securing the dinner money arrears, the school should advise the local safeguarding team (if deemed appropriate) and formally write to the parent/carer, explaining that the school is not obliged to provide a school dinner where advance payment is not forthcoming or where authorisation for free school meals has not been received. (See letter).

### **Monitoring and Recovery of School Meal Debts**

At each Governing body finance meeting, the Head Teacher will provide the Governing body with details of any outstanding dinner money debt and the current position regarding such debt.

The aim of this policy is to minimise the opportunity for debt balances to build up. The school reserves the right to begin proceedings to recover outstanding school meals debts and inform the local authority that a child is not being provided with a suitable meal at lunch time.

All write-offs of outstanding debt must be approved by the governing body / finance committee by the Head Teacher with reasons for no further action being taken.

### Weekly Text message 1

### Over £30 Text message 2

There is an outstanding lunch debt of \$LunchBalance\$ for \$Forename\$. As this amount is over £30 packed lunch should be provided until this is paid. Thank you
